Registration will occur at the Donald Dean Parking Lot on Rt. 706 across from the Pump n' Pantry in Montrose. The walk begins behind the Pump n' Pantry and continues to the Claverack building before returning back to the starting point.

Procedures for walkers

- 1) Always walk with your pet on a leash.
- 2) Walk with sufficient spacing between walkers to prevent dog fights.
- 3) If you feel ill tell someone to alert the medical personnel that will be nearby.
- 4) If you are getting tired, please rest off the trail, but where you can be seen by ANYONE passing by.
- 5) Running is NOT allowed.
- 6) All walkers with or without dogs must check in with team officials prior to their start.
- 7) All walkers must check out at the starting point at the completion of their walk.
- 8) When approaching walkers coming in the opposite direction:
 - A) Keep to the right (SINGLE FILE)
 - B) Shorten your leash
 - C) Keep your dog on your right side
 - D) Aggressive dogs should be taken off the trail to your right and under control until the approaching group passes.
- 9) To insure a safe walk one walker will walk with one dog.
- 10) Children walking a dog MUST be 16 years old or older and accompanied by an adult.
- 11) Walkers will start in groups and several minutes between groups to minimize confusion and are responsible to clean up their dog's messes.

WAIVER AND RELEASE OF LIABILITY**

1. In recognition of the risk of injury while participating in the No Animal Left Behind Walk-a-thon (Event), and as consideration for the right to participate in the Event, I hereby for myself, my heirs, executors, administrators, assigns, or personal representatives knowingly and voluntarily enter into this waiver and release of liability (Agreement) and hereby waive any and all rights, claims or causes of action of any kind whatsoever arising out of my participation in the Event, and do hereby release and forever discharge No Animal Left Behind Walk-a-thon and its affiliates, managers, members, agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns, business and its affiliates, managers, members, agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns, the event site and its agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns and all sponsors and/or beneficiaries of the Event (collectively Hosts) from any and all liability, claims, demands, damages, actions, or causes of action now existing or which hereinafter may arise as a result of my participation in the Event, whether any injury is caused by the negligence of the Hosts, the negligence of myself or third parties, the conditions of the course or any other cause.

2. I agree to indemnify and hold harmless the Hosts against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorneys fees, if litigation arises on account of claims made by me or anyone on my behalf.

3. I attest that I am physically fit and have trained sufficiently for the Event and I will not knowingly push beyond my physical limits at any time during the Event.

4. I recognize that various photographs, video recordings, and other media will be taken during the Event. I agree to grant the Hosts full permission to use any photographs, video recordings, or other media of the Event that contain my likeness for the purpose of promoting Susquehanna County Animal Response Team (CART) or the Event, or for any purpose deemed appropriate by CART.

5. For safety purposes, I agree to refrain from using headphones (and/or cellular phones) during the Event.

6. I acknowledge that this Agreement is the entire agreement between the Hosts and me, and that this Agreement cannot be modified or changed in any way by representations or statements of the Host or by me.
